Friday, Saturday, and Sunday: First walk 7:45am - Judging begins at 8:00am

MOVE-UPS

The deadline for move-ups for the first day your dog is entered is 6pm July 15, 2024. Day to day move-ups must be received within ½ hour after the last class of the day and must be in writing at the site. NO emails, faxes or phone calls.

MEASURING

There will not be a VMO at this trial. The judge of record will need to measure all dogs that do not have a valid height card if over 2yrs old or a temporary measurement if under 2yrs old, prior to the first run for the dog that day per Chapter 2, Section 5, Paragraph 5, Regulations for Agility Trials and Agility Course Test (ACT)

COURSE MAPS

Course maps will be posted to the website (www.awesomedogsagility.com) after midnight each trial day. The maps will also be posted at the trial site.

RESULTS AND RIBBONS

Results will be available in a 3-ring binder for each day. Ribbons are self-serve. Results will also be emailed to each exhibitor.

LEASHES

Dogs must be on leash at all times except when at the practice jump or when competing in the ring. No flexi-leads in the building or within 50 ft of the building.

CRATING

We have a HUGE space for crating. TARPS UNDER your crates are REQUIRED.

POTTY

There is a large grassy area beside the building. There will be trash bags for poop on stakes. Please don't place poop bags in the facility trash cans. Please try not to let your dog pee on the landscaping around the building.

VOLUNTEERING

There will be a volunteer coordinator each day. We all know trials can't run without the many volunteers. Please sign up to work at the trial. Your help is very much appreciated!
